The term of a standard patent is up to a maximum of 20 years from the deemed date of filing of the patent application. The proprietor shall pay the prescribed renewal fees in accordance with the Patents Ordinance and the Patents (General) Rules to keep the patent in force. Fees should be accompanied by the specified patent renewal form.

《專利條例》第 39(2)條規定 《漢以專利的營作提交日期在批予專利後第一個周年日起計,在第 3 年或繼後任何一年(視屬何情況而定) 展灣前,微付續期費再維持專利有效一年,但不得早於屆滿日期 3 個月前繳付。

Under section 39(2) of the Patents Ordinance, to keep the patent in force for a further year after the expiry of the 3rd or any succeeding year from the anxiversary of the deemed date of filing of the standard patent first occurring after the date of grant, the renewal fee shall be paid before the expiry of that 3rd or, as the case may be, succeeding year but not earlier than a date 3 months before that expiry

If no fee is received within the prescribed period, the patent will cease to have effect.
